


I therefore request that the same may be complied with and compliance be reported to this Department on priority basis.

I am to say that the matter regarding disposal of CNCP cases was discussed under item No. 7(12) of the joint meeting of Hon'ble the JJ Committee & POCSO Committee held on 25.04.2019 and the Principal Secretary, W & CD and MS, Govt. of Odisha apprised that 61.7% CNCP cases have been disposed of by CWCs and assured the Committee to achieve 90% disposal by June 2019.
