# Child friendly Space

# A programme by People's cultural centre [PECUC] ,Odisha as a response to super cyclone ,floods & Phailin in Odisha

PECUC started Sradha Abhijan – a campaign for love & affection ,care & protection and education after super cyclone 1999 .Sradha Bhavan –a child friendly safe space were set up as part of this programme. During course of time it emerged as a major intervention for children adopting various methodologies and strategies .The most recent example was after phailin .

**Objectives of Child Friendly Space :** 

To offer children opportunities to develop, learn, play, and build/strengthen resiliency after an emergency or crisis, or during a Lingering emergency.

#### PRINCIPLES:

- Ensure CFSs highly inclusive and non-discriminatory
- Use CFSs as a means of mobilizing the community.
- Ensure that CFSs are safe and secure.
- Ensure CFS are participatory, stimulating and supportive environments
- coordination with different stakeholders and multi-sectoral approach

#### Process for implementation of child friendly space :

- This is a set up under a tent in a safe open space / any school.
- Space identification for CFS .
- MoU with land owner /school authority / in case of public place permission from panchayat for Use of Land/Space for the CFS.
- Orientation of volunteers .
- Joyful engagement of children by trained volunteers.
- Formal and Informal Education that is more holistic and less academic Literacy and numeracy.
- Life skill education.
- Attendance Sheets for children , Timing of centre .
- Reporting Formats (for continuous monitoring and end evaluation, etc).
- Provision of Play Kits, First Aid Kits, Safe drinking water, learning materials . Health check up .
- Nutrition food , immunization etc linkages with Angan wadi ,School etc.
- Health education in new environments.

- Parent counseling,
- Trauma counseling of children.
- Following Child Protection standards.
- Following Child protection policy of the organization.
- Phase out or transition in a contextually appropriate manner .
- Producing orphan & other vulnerable children in need of care & protection before Child welfare committee for their rehabilitation.
- Mainstreaming children in formal schooling
- It is a transition time and place to prepare the children before they re-engage into their formal education system.

# Child friendly flood & Cyclone shelter :

#### **Objectives**:

• To create and promote a model of good practice for child safe flood& Cyclone resistant shelters in vulnerable and high risk communities.

#### **PROCESS** :

- Identification of land in coordination with Community ,local authorities, panchayat .
- Soil testing
- Legal procedure for land acquisition
- Formation of committee for Monitoring the construction with participation of child representatives
- .Sharing plan, design, estimate etc with committee & community.
- Identifying possibilities resource linkages & leverages convergence with govt schemes & programmes i.e. MGNREGS .RWSS ,SSA etc
- Children were involved from the beginning phase through DRR plans , they gave inputs for child safe flood shelters features , Preparedness education.
- Construction
- Handing over to community / Local Authority.

## Provision of Child friendly features in flood & Cyclone shelter :

- Separate wash basin[ low height ] for children
- Separate room for children with child friendly design , blackboard & Playing materials.
- Separate Toilet for children
- Painting on the wall with different colours
- Building shape -designed with child friendly manner.- Kendrapada- Pencil look, Balasore- One Pencil and one Butterfly design
- Safe drinking water storage facility
- Ramp facility



### Safe Child Friendly place will reduce risk and vulnerability

#### Convergence & leverages: [for setting up shelters] -

unique example of convergence amongst Community, Local NGO, INGO,Corporate,Panchayat,Government

- Building construction funded by Save the Children & ICICI Foundation
- Linkages with Government For land -District Administration , Education Authority , Panchayat Earth filling – MGNREGA Drinking water [tube well installation] – RWSS
- Community Mobilization , construction , preparedness education, monitoring ,ensuring linkages & leverages by PECUC .
- Monitoring of the building construction by the community with children participation
- Follow up maintenance by Local gram panchayat [one shelter ], School/Education authority [2 shelters]

#### **Objectives** :

• Promote disaster safety in schools through education, awareness planning & demonstration/mock drills.

#### Content of School safety Plan :

- Assist schools in preparing for future disasters.
- Prepare teaching material on school safety.
- Build capacity of teaching instructors, school staff on school safety.
- Assessment and Planning by children & adult
- Assessing Structural Safety , Non-Structural Safety
- Assessing Capacities and Resources for Mitigation, Response and Recovery
- Sensitization Meeting for Awareness to School Management
- Conduct School Safety Audit
- Formation and Training to the School-based Disaster Risk Reduction
- Awareness Activities and Dissemination of the Plan to Everybody in the School
- Conduct Regular Safety Demonstrations and Report to Committee
- Implementation of Risk Reduction Measures
- Evaluation of the Plan to Improve Effectiveness
